Introduction

This section of the manual will take the user through an overview of the SpeedSearch process and how F3 Lookups are used. The steps are as follows:

What to Do With the Data

A. CONCEPTUAL OVERVIEW OF SPEEDSEARCH STRUCTURE

SpeedSearch allows the user to access detailed information for Service Repair, Inventory, Order/Invoice Processing, Purchase Orders, Accounts Receivable, Accounts Payable, Sales Analysis and General Ledger without having to access each module directly. The user can access SpeedSearch data *from any screen in the system that you see the Binoculars Icon displayed.*

Your **F3** or **Lookup function** is designed to be used within *specific fields* throughout your system. As you move through your ACS/MASTER system there will be *fields* that will allow you to perform a Look up, or to select from a list of information; F3 is designed to be used in these fields.

B. BASIC PROCESS TRAINING

How to Find Data

In this section we will train the user on how to navigate through the Lookups and Accounting sections of SpeedSearch to find the data they are looking for. You will find a brief explanation for each of the remaining sections and the information available through these searches. How to Find Data: SpeedSearch

When working in ACS/MASTER, you will see small boxes or ICONS displayed across the top of each menu. Locate and let your mouse hover over the Binoculars ICON, this is SpeedSearch.

To select SpeedSearch, click once on your Binoculars ICON

It is possible to SORT this information by clicking on any header field.

EXAMPLE: Clicking once on the Alternate Sequence header will sort the all data based on the information in this field. One click sorts it alphabetically; clicking it again will reverse the sort sequence.

The START WITH field will allow you to search for specific customers by entering the first few characters of the customer name in the Start With field and then clicking once on the NAME header. This will sort all of your customers by name beginning with the characters that you entered.

Similarly you can enter a few characters of the customer number and click once on the CUSTOMER field to sort by customer number. This process can be repeated in any of the columns displayed.

NOTE: As you begin to navigate through your system, you will see information that will be "color coded". In this case you will see customers that are inactive displayed in red, customers on credit hold displayed in blue and customer containing customer notes displayed in green. The legend for this process is located in the left lower corner of your screen.

Click once on the customer you wish to select.

Now you have multiple options:

Selecting the drop down arrow in the upper right corner of the screen will display further "drill down" options that you may select from:

Ship-To Display Comment Display Customer Note Display

You will select an option by clicking on it once.

Generic Data Base Lookup

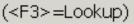
The Generic Data Base contains a complete listing of all files used in the ACS/MASTER System. As such, it is strongly suggested that access be granted to Administration, ACS Customer Support and IT only.

The information available here includes an Error Log File that records all errors that may occur in the system; and System Log Files that records all processes that occur in your system by user.

Training for the use of this option will be set up by your Project Manager or by contacting Customer Support.

F3 Lookup – The **F3 function key** is available in most tasks as a means of looking up customer names, job numbers, inventory items, etc.

EXAMPLE: When in a Customer Number field, F3 can be utilized to obtain a complete listing of all customers. Then it is a simple matter of selecting the correct customer. Any time you are in a field which utilizes the F3 function, you will see the F3 option displayed at the bottom of your menu.



It is also possible to perform lookups using the **Field Lookup** option located at the top of your menu. Simply move your curser to the field you need to find information for, and select the Field Lookup option.

Your final option for field searches is the **Right Button** of your mouse. Put your curser in the field you wish to search in and click the right button of your mouse once. This will either take you to the available options for the field you are searching, or it will display a "pop up" box with further options.

As you become familiar with the specific types of information available through your SpeedSearch functions, you will find the LOOKUP options and ACCOUNTING/PROFILE options approach Vendor, Customer and Inventory information differently.

LOOKUP functions begin with a complete database listing of the option you selected; while PROFILE requires the entry of a specific Vendor, Customer or Inventory item.

Eventually, however, the "drill down" process accesses the same files; so you can ultimately find the data you are searching for in BOTH options. It then becomes a personal preference issue of "how to find the data more quickly".

Invoice G/L Postings Display

One of the most powerful "drill down" options available is the Invoice G/L Postings Display. As you begin to utilize the drop down menus you will find this option is available when accessing any AP or AR Invoice History or AP Check Detail options.

Beginning and Ending Account# - allows you to perform a search for an account number or a range of account numbers

Wildcard - enables you to select accounts that have common numbering as part of their identification. EXAMPLE: if you want to select all accounts that end with 10, enter ###10 in the Wildcard field.

Beginning and Ending Transaction Date – give you the option of selecting a specific date or a range of dates.

Beginning and Ending Period/Year – will capture all transactions for an entire period or range of periods.

Journal ID – Each GL posting is assigned a Journal ID from the transaction that created it. EXAMPLE: Job Material/JM, Cash Receipt/CR, Journal Entry/JE, etc. Using the drop down arrow it is possible to select from a list of Journal IDs if you wish to narrow down the search by the type of transaction.

Audit Number – Each of the Registers throughout your system will generate an Audit Control Number that identifies the General Ledger Postings created by the transactions included in the register. Entering the Audit number for any given register will provide a report showing all of the transaction included for that audit number.

Application Options – This option allows you to select from None, Customers, Vendors and Jobs if you would like to use the remaining fields to narrow down your search.

Application Main Options and Secondary Options – these information fields will be specific to the criteria entered in the Application Options.

Reference 1-6 – The Reference fields available will be determined by the Journal ID code entered or by the Application Options that have been entered. If you have reference information from related reports, you may also enter this data in your 6 reference fields.

EXAMPLE: If you are retrieving data from Accounts Receivable Cash Receipts, one of your reference options could be the Customer Check Number. Entering the specific check number would narrow the resulting information generated by the report.

Detail or Summary – The report may be run in Detail or Summary format.

NOTE: To utilize Non Stock information and Sales Inquiries, it is important to be consistent in your numbering system for Non Stock Items.

In this case that includes Line Seq#, Line Code, Warehouse, if the item was Drop Shipped, Product Type, Item Cost, if pricing was manually entered and if the item was part of a Kit.

This type of detail is available for numerous documents, such as, Sales Orders, Purchase Orders and Purchase Order receipts; you will find it available when your drill down options include a "Display DETAIL" option.

However, by entering Item#, Invoice date, Customer PO or Descript, it is possible to narrow your search.

EXAMPLE: Your customer wants to purchase an item he bought 6 months ago, but does not remember a special Non Stock item number. He can, however, give you the Purchase Order number he used for the transaction. Using a combination of the Customer and Purchase Order numbers will produce the items included in the sale.

Please see the *System Maintenance* section of your manual for further information regarding the Generate Executive Summary function. This process can be run at any time; when generated, data for all companies is created.

Both Summary Analysis and Calendar options allow the user to select a specific month and year to view. You will also select the display of amounts, units or averages.

The **Summary** display is divided into four sections:

AR and AP Analysis Order Analysis Sales Analysis Inventory Analysis

Summary of Accounts Receivable

AR Analysis will display the current and immediate past two months of summary along with prior and future information.

Balances of open AR invoices are aged by invoice due date into the correct month/day.

Summary of Accounts Payable

AP Analysis will display the current and immediate past two months of summary along with prior and future information.

Balances of open AP invoices are aged by invoice due date into the correct month/day.

Summary of Sales Orders

Open Sales Orders line items are aged using the line item ship date, if one exists. If no line item ship date has been entered, then the ship date from the order header is used. If no ship date has been entered, then the order date is used.

Line item extensions are then accumulated by the month/day.

Sales Tax, Freight and Discount amounts are not included in the order totals. Sales Orders displays current and future months, as well as prior and future totals

Summary of Purchase Orders

Open Purchase Order line items are aged using the line item required date if one exists. If no line item required date has been entered, then the order date from the PO header is used. Line item extensions are then accumulated by the month/day. Purchase Orders displays current and future months, as well as prior and future totals.

Summary of Sales Analysis

Invoice history total cost amount are aged by invoice date into the correct month/day. Gross Profit Percentages are derived by dividing the profit (total sales minus total cost) by the total sales amount.

The total percentages for each month are display for the current and two prior months, as well as prior and future.

Summary of Inventory

On Hand is the sum of each warehouse's on hand amount. This amount is calculated by multiplying the warehouse item cost by the current quantity on hand.

For lotted/serialized items, the actual cost associated with the lot or serial number is used instead of the warehouse item cost.

If LIFO/FIFO costing is used, the costs for each LIFO/FIFO tier for each warehouse (and the associated quantity) determine the total on hand amount.

Committed amount is the sum of each warehouses' committed amount. This amount is calculated by multiplying the warehouse item cost by the current total committed quantity at the warehouse.

For lotted/serialized items, it is the actual cost associated with the lot of serial number instead of the warehouse item cost.

If LIFO/FIFO costing is used, the cost for each LIFO/FIFO tier for each warehouse (and the associated quantity) determine the total committed amount.

Available amount is the difference between and on hand amount and the committed amount.

Work in Process amount is determined by calculating all labor and material that has not been invoiced on jobs. The WIP amount does not include un-posted labor and will only display in the month the Executive Summary was generated. The WIP amount will be zero for prior and future months.

The **Calendar** display allows the user to select from the following options:

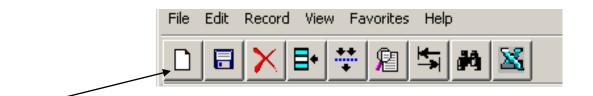
The calendar option displays a day-by-day breakdown of any of its summarized categories. When you first select this option, the month displayed is the current month. The drop down arrow allows to you make a month selection and enter the year. As in the Summary format, you will also be able to select from Amounts, Units or Averages.

C. DATA PROCESS TRAINING

What To Do With The Data

Having stepped through the process of *finding data* using SpeedSearch and F3/Lookup, we now will review what options are available for the processing of this data.

Many of the Speed search drill down screens will have Icons or options buttons in the upper left corner of the menu. Wherever these options appear, they can be used to process your newly acquired data. All of the options listed below may not be available for all search results, those will be "grayed out".



Restart Current Lookup

This option is useful when you have performed a search and have the results displayed on your screen. If you wish to begin a new search, Restart Current Lookup will return you to the original blank query.



Save Current View Delete Column

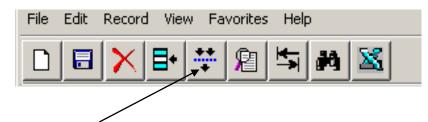
It is strongly suggested that these options ARE NOT used by the everyday user. The Arrange Columns option, reviewed below, should be used when making any changes to the SpeedSearch display columns/screen for any specific user.

IMPORTANT: Save Current View and Delete Column options can, when used incorrectly, result in systemic processing issues. Please contact ACS Customer Support to review these options before making any changes.



Pick Selected Record ,

This option has been superseded by new other SpeedSearch options.



Filter Records

This option can be used to refine or filter the result of your query.

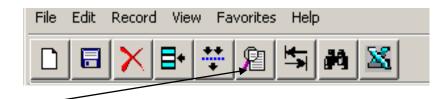
Upon selecting this option your "Filter Data" box will pop up. Here you can enter the values you wish to search or filter by. The options available in this process will be determined by the subject matter of your search.

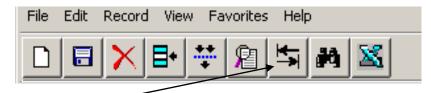
Value – Enter the specific value you wish to search for



Find Records

This option performs the same function as your F3 key. It allows the user to perform a "lookup" to find the options available in any given field.

EXAMPLE: Selecting this option in a Customer Number field will provide a list of valid customer numbers available.



Arrange Columns

This feature gives the everyday user the opportunity to format the SpeedSearch screens they use the most. By selecting the column order, each user can determine what information will display each time they access this search.

-Select NO to exit the search without saving the changes made to column display.

NOTE: Using the Arrange Columns feature will modify the SpeedSearch screen for this user only and will have no impact on the system or other users.



EXCEL _

Any screen that displays the Excel "button" provides the user with the option of exporting the data to an Excel spreadsheet. Many of the SpeedSearch "drill down" options have this interface available.

NOTE: this option requires the user to have Microsoft Excel 2000 or newer installed on their workstation and have the Macro Security set to a Medium or Low setting.

Once your search results are displayed, simply select the Excel option to have the data formatted. Once the spreadsheet is created, the information must be processed as any other Excel document. Your system will not save this document, you must perform a Save if you wish to keep the resulting spreadsheet.
